

2027 SALLY FAQ



REGISTRATION:

Registration will be open from September 15th until October 31st, 2026 and must be completed online by clicking the registration tab on the Sally website www.thesally.com

- **SUBMITTING THE APPLICATION FORM DOES NOT REGISTER YOU AUTOMATICALLY**
- **ALL ACCEPTANCE IS SUBJECT TO COMMITTEE APPROVAL**
- **THE SALLY COMMITTEE WILL MEET IN EARLY NOVEMBER TO SET THE FIELD**
- **A CONFIRMATION EMAIL WILL BE SENT TO THOSE ACCEPTED**

ENTRY FEE: \$515

Entry fee of \$515 will only be charged when the field is set to the credit card provided upon registering.

CANCELLATION POLICY:

Entry fee will be refunded if notified by December 15th, 2026.

No refunds are issued after December 15th, 2026.

WAITING LIST:

Players that are not in the field will be placed on a waitlist.

FIELD LIMIT:

Championship Division- 84

Rockefeller Division- 12

SALLY CHAMPIONSHIP DIVISION

- Max Handicap Index 6.0
- 72 holes played from 6200 yards

ROCKEFELLER DIVISION

- Max Handicap Index 10.0
- 54 holes played from 5600 yards (space is limited)

Format: 72 hole stroke play

- Rockefeller will consist of 12 players and will consist of three rounds
- The Sally field size will be 84 players and there will be a cut of the field size to 60 players and ties for the final round.
- The first three days of competition will be a Split tee start beginning at 8:30 off #1 & #10.
- The final round will be a straight tee time configuration off #1.

Johannsen Mid-Amateur Tournament

- Play is in conjunction with the SALLY Tournament.
- Eligible players are those that are over the age of 22 when the competition starts and is not on the roster of any college or university golf team and competing in the SALLY Championship Division. Players competing in the Rockefeller Division are not eligible to participate.
- The winner is the player that has the lowest 72 hole gross score in the SALLY Championship Division.

CARTS/CADDIE: Carts will be available for tournament rounds on a first come first served based on registrations. Each player will be paired in groups and each group will have a maximum of two carts. Players may also walk but must be able to keep pace. Players are allowed caddies during the event. Caddies may ride in carts only if there is room. Players have first right to carts. **All carts must be DRIVEN by a person at least 16 years of age WITH a valid driver's license.**

SPECTATORS: Non-member spectators will be permitted for the 2027 SALLY tournament. Spectators must use Pool or outside restroom facilities. **Spectators and Caddies will not have access to the Clubhouse.**

CLUB ACCESS: Access to all areas of the clubhouse will be restricted to players, their guardians (if applicable), Clubhouse Pass Holders, and members. Locker rooms and showers will not be available. **ONLY Clubhouse Pass holders** will have access to the same player's meals noted on the Calendar of Events.

PRACTICE ROUNDS: Monday, Jan. 4th is included with the entry fee. **The course will not be available for practice rounds on Tuesday January 5th due to the Member Sally Golf Tournament. The Driving Range will open for players at 11 AM until 5 PM.** Additional practice rounds (excluding Monday) need to be scheduled by contacting the Golf Pro shop and will be charged \$100 plus tax per player.

MEMBER SALLY TOURNAMENT: All participants in the Member Sally must indicate on their registration form at the time of entry. **There are only 50 spots available, and it's important to consider participation in this event when you register. Reminder: the course will not be available for practice on Tuesday other than this event and the practice facilities from 11 AM to 5 PM.** Sally Players will be paired with members for this additional round at no cost to the participant.

SPECIAL PARKING NEEDS: RV's, oversized campers are not permitted on property or in the club parking lot.

HOUSING: Participants will have the opportunity to request Housing with a Host Family by checking Yes/No box on their registration. Participants will have a comment section for specifics – desire to stay with previous host, special needs or allergies, transportation needs, pets etc
Information from Participants: Transportation needs, Arrival time, Special dietary needs
After being assigned a Host, Participants should contact their Host directly to confirm arrival and departure times. If Participant decides not to stay with a Host Family or withdraws from the tournament, she must contact the Housing Chair as well as her assigned Host Family that she will not be staying in private housing.
